About The Turks and Caicos Islands Airports Authority

The Turks and Caicos Islands Airports Authority ("TCIAA") (established under The Airports Authority Ordinance, Ord.11 of 2005) is responsible for constructing, controlling, and managing airports, and providing and maintaining runways, taxiways, and terminals for the efficient operation of airports in the Turks and Caicos Islands. Its current portfolio consists of owning and operating six airports while providing air navigation services for the low-level airspace above the territory. Our mission is to provide world-class airport facilities and operations through high standards in safety, security, quality, efficiency, innovation, and customer service, recognizing their importance to the overall socio-economic development and strategic growth of the Turks and Caicos Islands.

About The Project

TCIAA is currently implementing a significant project to integrate radar surveillance services into its existing air navigation services program. This three-year integration initiative aims to enhance safety, efficiency, and capacity within the Turks and Caicos Islands' airspace. A consultant has been engaged to assist in defining the project scope, which includes:

- Transitioning TCIAA's Air Traffic Control (ATC) operations to radar-based traffic management.
- Optimizing TCIAA's airspace utilizing the capabilities of the new radar system.
- Procure necessary capital assets (radar equipment, ATC training simulator, etc.).
- Identification of a suitable facility to house the new systems.
- Develop and implement comprehensive training programs for ATC personnel.

About The Role

The Project Manager will be crucial in successfully implementing this critical project. Working closely with the consultant and internal stakeholders, the Project Manager will oversee the day-to-day management of the three-year integration program. This includes leading the procurement process for all necessary capital equipment and acting as the primary TCIAA representative throughout the integration process.

Responsibilities and Key Deliverables

Project Management Leadership:

- Lead all aspects of the radar surveillance integration project, ensuring adherence to the agreed-upon scope, budget, and timeline.
- Lead project planning, scheduling, budgeting, and risk management activities with the support of TCIAA's appointed external advisors in the project.
- Oversee the implementation of the consultant's recommendations and the project implementation plan.
- Monitor project progress, identify and resolve potential issues, and implement corrective actions as needed.

Procurement Management:

Lead the procurement process for all capital assets required for the project, including radar equipment, ATC training simulator, and associated simulator. This oversight includes:

- Develop and manage procurement plans.
- Drafting and issuing Requests for Proposals (RFPs), Invitations to Tender (ITTs), and other procurement documents.
- Evaluating proposals and selecting qualified vendors.
- Negotiating contracts and managing vendor relationships.
- Overseeing the delivery, installation, and testing of equipment.
- Ensure compliance with all TCIAA and TCIG procurement policies and procedures.

Stakeholder Management:

 Build and maintain strong relationships with key stakeholders, including the consultant, vendors, regulatory authorities (e.g., TCCA), and other relevant parties.

- Effectively communicate project progress, issues, decisions, and risks to all stakeholders.
- Proactively address stakeholder concerns and resolve conflicts.

Technical Oversight:

- Work closely with consultants and technical experts to ensure successful integration of the new radar programme and systems.
- Provide technical guidance and support throughout the project lifecycle.
